

# How were your RIGHTS taken away?

On March the 16th 2020, our lives were turned upside-down through the Coronavirus Act 2020. The most draconian legislation to exist in over a century. An unlawful lockdown began and a stay at home order was mandated. Under the guise of a pandemic, the government passed many laws infringing on our Human Rights.

The Coronavirus Act, along with the misuse of the Public Health (Control of Disease) Act 1984, turned the UK into a police state overnight. Small businesses were forced to close, elections were suspended, children were not allowed to go to school, football pitches and libraries were shut, yet fast food chains stayed open. Domestic violence sky rocketed, mental health issues and suicides increased, and prisoners were subjected to a 23.5-hour lockdown. At the same time, thousands of innocent citizens were fined under the Coronavirus Act for simply going for a walk, doing their exercise, or being seen in public with more than one person.

Protests were made illegal and censorship was at an all-time high. While those who questioned the narrative were, and still are, demonized by the media, thousands of innocent people were assaulted by the police and detained unlawfully under **The Coronavirus Act 2020**:

Schedule 21 gives arbitrary powers to the police, immigration officers and public health officials to detain “potentially infectious” members of the public, including children, potentially indefinitely, in unidentified isolation facilities.

Schedule 22 gives Ministers the power to single-handedly ban any type of gathering, including protests, vigils and political assemblies.

# Your Human Rights

They are Universal. Adopted by the General Assembly of the United Nations in 1948, the Universal Declaration states fundamental rights and freedoms to which all human beings are entitled.

**Article 13.1:** Everyone has the right to freedom of movement and residence within the borders of each state.

**Article 13.2:** Everyone has the right to leave any country, including his own, and to return to his country

**Travel BANNED**

**Article 18:** Everyone has the right to freedom of thought, conscience and religion; this right includes freedom to change his religion or belief, and freedom, either alone or in community with others and in public or private, to manifest his religion or belief in teaching, practice, worship and observance.

**Churches CLOSED**

**Article 19:** Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers.

**Worldwide CENSORSHIP**

**Article 20.1:** Everyone has the right to freedom of peaceful assembly and association.

**Protests BANNED**

**Article 23.1:** Everyone has the right to work, to free choice of employment, to just and favourable conditions of work and to protection against unemployment.

**Article 23.2:** Everyone, without any discrimination, has the right to equal pay for equal work.

**Small businesses CLOSED**

**Article 26:** Everyone has the right to education.

**Schools CLOSED**

Whereas it is essential, if man is not to be compelled to have recourse, as a last resort, to rebellion against tyranny and oppression, that human rights should be protected by the rule of law.
