The government has inexplicably decided to ignore their own committee and expose this impressionable and vulnerable group to the risks of the vaccine with no medical justification (see overleaf for more details).

Governments and pharmaceutical companies have put profit before public health on many occasions throughout history and it seems we may be witnessing this terrible practice once more.

Gillick Competence

What is it?

A child in the UK is able to consent to certain medical treatments without parental permission or knowledge by using what is known as Gillick Competence in certain circumstances.

Schools may use this law to offer the Covid-19 injection to your child whilst at school in the absence of any instructions from you in this matter.

Given the irrational decision by the UK government to ignore the JCVI, you may wish to discuss this matter with your children and inform the school of your instructions.

-That you do not give permission for your child to be injected without your consent

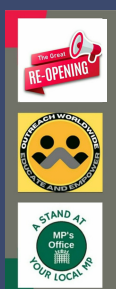
